MESSAGE FROM THE STAFF DIRECTOR OF TECHNICAL ACTIVITIES

As it has been defined in the past by Dr. Richard M. Emberson, IEEE (co)sponsorship of a conference constitutes genuine technical involvement. The decision of (co)sponsorship largely rests with the Societies, Groups and Councils which are the IEEE guardians of technical excellence. In addition to technical involvement, there is in many cases financial involvement as well. In all cases there is some related expense in that all (co)sponsored conferences entail the cost of indexing.

Through the years, IEEE (co)sponsorship has become identified with conferences of the highest technical level that are either national or international in scope. The proceedings of these conferences are distributed to about 200 nonmember customers (usually libraries), who, under IEEE's Open Order Plan (OOP) Option 1, receive one or more copies of all records of (co)sponsored conferences. In addition, there is an increasing number of customers who subscribe to records of specific conferences as categorized in any of the eight available suboptions under OOP Option 1. In either case, the customers (libraries) sign an agreement to receive one or more hardbound copies of our conference publications without any advance knowledge of its price. Recently, some librarians have begun to question the absence of a provision for returning a conference record, for reasons other than the physical quality of the merchandise.

The purpose of bringing these matters to your attention is to raise your awareness of the importance and implications of IEEE (co) sponsorship, so that we do not burden the librarians with conference records of marginal archival value and to minimize any unessential indexing costs.

HIGHLIGHTS OF THE TAB OpCom/TAB MEETINGS, FEBRUARY 15-16, 1979

(Note: This follows the sequence of the Executive Summary of the Agenda published in the January/February edition.)

REFERENCE No. 18/TAB OpCom & TAB Meeting Minutes will be available by the middle of March.

- 1. 1979 G/S/C Budgets—TAB OpCom and TAB unanimously approved the budgets as presented.
- 2. Revision of Bylaw 305.1-Composition of Awards Board—TAB OpCom and TAB unanimously reaffirmed the proposed revisions which were originally approved in December 1978.
- 3. SME Position Paper—TAB OpCom approved the position paper in principle, without enclosures. (9 in favor, 1 opposed, 2 abstentions). TAB voted to go on record stating that "TAB supports the efforts of the Society of Manufacturing Engineers to obtain increased government support and recognition for research and development of advanced manufacturing technology." The consensus was not to endorse the position, but only to show support of the intent of the posi-

tion. (BoD endorsed in principle the general concept of the SME position.)

- 4. TAB voted to go on record as requesting that CHMT be requested to develop a position paper on the National Role and Importance of Manufacturing and Engineering Technology.
- 5. National Systems Center—No action was requested of either TAB OpCom or TAB at this time, but possibly in August. The item was discussed by both bodies.
- 6. CSIT Position Paper—TAB OpCom and TAB voted not to consider this item without having a finalized version of Policy Statement 14—IEEE Position Papers approved by the BoD.
- 7. Engineering Societies Commission on Energy (ESCOE)—TAB Op-Com revised the presented amendment such that the second and third "Wheras" were deleted, and unanimously approved the revised amendment. TAB voted to endorse the resolution concerning ESCOE which was originally presented to TAB in August by Hilton Brown.
- 8. Committee on Health Care Technology Policy—TAB OpCom and TAB unanimously approved the formation of a joint TAB/USAB committee on Health Care Technology Policy.
- 9. Technology Forecasting and Assessment Committee (TF&A)—TAB OpCom and TAB voted to discontinue the TF&A Committee on the basis that there was not enough need for it.
- 10. *MEDCOR*—TAB OpCom voted 5 in favor, 1 opposed and 6 abstentions on the general question of having a health care testing program (not MEDCOR specifically).
- 11. New Field Awards Program—TAB reviewed the responses to a questionnaire distributed by J. Barry Oakes to G/S/C Presidents. No action was requested at this time. The G/S/C officers were urged to work through the Committee to address their concerns, particularly during 1979, when the Awards Board is being reviewed.
- 12. TAB Search Committee Charter—TAB OpCom referred this item to TAB for their review and comments. TAB endorsed an amended version of the Charter.
- 13. Possible New Committee on Ionizing Radiation—TAB OpCom passed any discussion of this issue based on a lack of TAB interest in the formation of such a committee. TAB voted not to form a new committee to cover the field of ionizing radiation.
- 14. Selection of Technical Experts as Witnesses in Congressional Budget Hearings—No action was requested of TAB OpCom; the matter was discussed. TAB discussed this item, and the consensus of the discussion was that USAB should contact all of the Division Directors directly, who then would contact the G/S/C Presidents in the appropriate areas of expertise.
- 15. Policy Statement 14-IEEE Position Papers—TAB OpCom referred this item back to committee for additional wordsmithing, and decided not to bring this item up for discussion with TAB at this time.

 16. Policy Statement 6.2-SPECTRUM and "The Institute" Editorial Policy—TAB OpCom unanimously endorsed this Policy Statement. No action was requested of TAB, only discussion.
- 17. Policy Statement 7.8-Code of Ethics—TAB unanimously endorsed this Policy Statement as presented.
- 18. Policy Statement 7.9-Matters of Ethical Principle—TAB OpCom unanimously endorsed this Policy Statement.

OTHER ACTION ITEMS:

- TAB voted for a definite commitment on the part of TAB to provide proper training for G/S/C Presidents.
- Management Training Seminar—TAB unanimously voted to hold a Management Training Seminar for G/S/C officers on May 3-4 in Washington, D. C., in conjunction with the U.S. Technology Policy Conference.
- TAB unanimously voted that TAB Newsbriefs be appended to the Minutes of each meeting.
- Next Meetings—The next TAB OpCom/TAB meetings will be held on:

April 25—New York (TAB OpCom meeting-tentative depending on the formulation of a substantive Agenda)

June 27—O'Hare-Chicago (TAB OpCom meeting-tentative depending on whether or not an April meeting is held, and the formulation of a substantive Agenda)

August 2—Denver, Colorado (TAB OpCom dinner meeting)

August 3—Denver, Colorado (TAB Meeting)

December 6—New Orleans, LA. (TAB OpCom meeting)

December 7—New Orleans, LA. (TAB meeting)

• TAB Finance—Considerable discussion took place on the increased burden on Societies in meeting their expenses of TAB headquarters operations, in view of the IEEE support remaining constant in spite of inflation and the increased need for services. This situation is affecting the smaller Societies more seriously. It will be reviewed by the TAB Finance Committee.

Concurrently, the Finance Committee has undertaken to work toward a more satisfactory distribution of common income and expenditure items

• International Traffic in Arms Regulations (ITAR)—There was a discussion examining the need for any action on the part of IEEE in matters affecting publication/presentation of material on cryptography.

The dichotomy between the country's need for laws governing national security and the individual freedom of speech was carefully analyzed by Dr. Getting. After considerable discussion the consensus emerged that no action is urgently needed, realizing that people working in these fields are usually knowledgeable about the laws and should exercise their individual judgement.

AES President Louis Urban will review the ITAR issue and report at the next TAB meeting.

- *TAB Manual*—A preliminary copy of the two-volume TAB Manual will be distributed in about one month.
- TAB & TAB OpCom Agendas—Following the recommended procedures for the IEEE ExecCom and BoD meeting Agendas, TAB agreed to experiment with the enclosed proposed Standard Instructions for Preparation of Agenda Items for Meetings of IEEE Technical Activities Board and TAB OpCom.

Pursuant to Policy State 9.6.D., the BoD determined that 1979 meetings of the Board would be open to Section/Chapter officers, Council and Area Chairmen and Society/Group/Council officers as observers.

3. ELECTION OF REGION 10 DIRECTOR: BYLAWS 201.1, 203.1, 301.1, 311.7, and 313.5 were revised to show Region 10 Director is elected exactly like other Regional Directors.

4. BOARD NOMINEES FOR 1980 PRESIDENT AND EXECUTIVE VICE PRESIDENT

5. 1979 BUDGET for the entire Institute was approved by the Board of Directors and is enclosed in summary form in the NEWSBRIEFS Supplement. (Please note that many operating departments in the Institute have budgets which do contain considerable transfer of funds in both the income and expense columns. The net column, however, should be perhaps the most meaningful one. On the other hand, the budgets for USAB, Region 10, and the S/G/Cs are significant as they carry a small amount of transfer of funds.

6. THE INSTITUTE PROCEDURES REGARDING IEEE ANNUAL ELECTION

These update procedures as amended at the meeting were approved. The document will be published in THE INSTITUTE, ELECTRICAL ENGINEERING, and will be furnished to all known candidates for the elective offices.

7. 1979-1980 FORTESCUE FELLOWSHIP

The Executive Committee approved Scott H. Goodwin as the recipient of the 1979–80 Fortescue Fellowship, with nine alternates designated in case he is unable to accept.

8. INVOICE FROM EJC

The Engineers Joint Council (EJC) has levied an assessment for nonmembers of EJC having representatives on its 1979 committees and commissions. IEEE, invoiced \$4,250 for its participation on the U.S. National Committee of the Pan American Federation of Engineering Associations (UPADI), will terminate its position on this Committee.

9. CONCEPT OF IEEE PRESIDENT-ELECT

The BoD supported the concept of the annual election of a Presidentelect to serve one year in that capacity, followed by one year as President, and a succeeding year as Past President.

SOVIETS INVITED TO COMAR MEETING

At their dinner meeting to be held on June 20, 1979, in Seattle, the TAB Committee on Man and Radiation (COMAR) plans to invite a group of Soviet scientists who will be attending the International Union of Radio Science meetings scheduled concurrently in that city. An informal exchange of viewpoints on radiation standards is expected to take place.

CHINESE ENGINEERS ATTEND TWO IEEE CONFERENCES

A study group of five engineers from the Chinese Electronics

Society attended the International Solid State Circuits Conference in Philadelphia this February and then participated in a four-week tour of technical facilities specializing in solid state circuits. Dr. William J. Spencer, President of the Solid States Circuits Council, served as chairman of the host committee for the visit which included stops at RCA, Westinghouse, Carnegie Mellon, Stanford, and Motorola among others.

Concurrently, the Computer Society hosted five professors from Quinghua University in Peking at COMPCON '79 in San Francisco. Leaders of the study group met with Dr. Tse-yun Feng, 1979 Computer Society President, and Mr. Merlin G. Smith, 1973 Society President, when the two men served on the 1978 IEEE Delegation to the Chinese Electronics Society. Plans have been made to accommodate the Quinghua professors for a four-week stay in the U.S.

TAB FINANCE REPORT

1979 GOALS FOR TAB FINANCE COMMITTEE

The first 1979 meeting of the TAB Finance Committee was scheduled for March 15th. Dr. Cyril J. Tunis, Chairman, stated that the main issues to be considered by this year's Committee will be the financial condition of some smaller Societies; distribution to S/G/Cs of TAB Administration charges and Non-Member (FULL) subscription income; and the development of the 1980 budgets for TAB and the S/G/Cs.

\$60K TAB CHALLENGE

The Board of Directors has decided that in view of favorable 1978 year end operations, the S/G/Cs should not be burdened with the \$60K TAB Challenge. The staff appreciates the numerous pledges made but will not need them now.

FOCUS

(Condensed answers to important questions of general interest.)

INCOME FROM COPYRIGHT PAPERS

Starting in 1978, IEEE adopted the policy of requiring the release of authors' copyright in favor of IEEE as a precondition for publication. Most of the papers are individualy coded to facilitate collection of income from systematic photocopying.

A private nonprofit organization, the Copyright Clearance Center, came into existence to enable systemic photocopying and distribute income to copyright owners. The Center is experiencing financial difficulties in becoming operational and has requested assistance. Realizing the potential benefit of the Center, the Institute provided financial aid and decided to forego the minimal copyright income for 1978 and 1979. When the Copyright Clearance Center does become fully operational, we will have an additional source of income and obtain data on the popularity of our publications.

S/G/C FINANCIAL STATEMENTS

Many Society officers have asked detailed questions about financial statements. While we are happy to address any specific concerns, we do wish to point out that answers to general questions can be found in the TAB Finance Manual. We also wish to remind you that the staff is responsible for carrying out the existing policies and finds it difficult to negotiate deviations. Formulation and revision of the policies are largely done by volunteer officers, and need the approval of the IEEE Board of Directors.

PROMOTION OF PUBLICATIONS

Currently, available resources are limiting our efforts by which a number of publications can be promoted simultaneously. Examples are: IEEE Publications Bulletin (sent quarterly to our 14,000 nonmember customers); Conference Recorder (sent to members based on their technical interest profile); Catalogs; and listings in SPECTRUM, TRANSACTIONS and JOURNALS. At this time, we are unable to undertake the promotion of individual publications but advise you to announce their availability in appropriate newsletters.

INVENTORY & SALES REPORT

The desirability of a periodic Inventory & Sales Report has our wholehearted support. We currently have about 600 different conference records in our warehouse and information on the sales history of a particular conference record is difficult to extract. A meaningful report will require the careful attention of all operating departments of IEEE, and must be machine-generated. Staff is working in this direction and seeks your patience and understanding.

EXTERNAL INTERFACE

NATIONAL PAPER PUBLISHED FOR INPUT AT U.N. CONFERENCE

The State Department has just issued the U.S. National Paper for presentation at the 1979 United Nations Conference for Science and Technology for Development to be held in Austria later this year. A section on scientific and engineering organizations lists the IEEE as a leader in the field of transmitting technological information. Copies of the paper may be obtained by writing to the State Department, Washington, D.C. 20520.

PUB NEWS

The IEEE Publications Board held its first meeting of the year on February 8th at New York Headquarters. The Board engaged in lengthy discussions on matters pertinent to SPECTRUM and THE INSTITUTE, in particular the proposed procedure for coverage of IEEE elections. Chairman Robert Lucky will shortly send out a questionnaire to seek the opinions of members. The schedule of future PUB meetings may be found in the TAB Administrative Calendar in this issue.
