


Southern District Technical Meeting and Student Branch Conference

Southern District Technical Meeting — Program -

The Program

The Southern District of the American Institute of Electrical Engineers is comprised of 11 Sections and 18 Student Branches in the states of Florida, Alabama, Mississippi, Louisiana, Georgia, Kentucky, Tennessee, South Carolina, North Carolina, and Virginia. This will be the first time that a District meeting has been held in the state of Virginia.

The program will consist of three morning sessions, two afternoon sessions, two evening sessions, and a session on student activities, Wednesday afternoon, November 17. Subject matter of general interest covering problems brought to the fore by wartime conditions has been included.

In accordance with AIEE wartime policies all programmed social activities have been omitted.

Special Features for Students

Delegations are expected from a number of the Student Branches and a student session has been arranged by Professor Claudius Lee, Chairman, District Committee on Student Activities. This session will be held Wednesday afternoon. The program will be in charge of the students and several papers will be presented.

Arrangements can be made for consultations between students and industry representatives. This will permit students to ask questions and familiarize themselves with the requirements and opportunities in some of the fields of electrical engineering. Students should indicate at the time of registering whether or not they wish such consultations arranged and in what field of electrical engineering they are particularly interested. A schedule then will be arranged.

Dinner Meeting

Each student who registers will be taken to the Tuesday night dinner by a member of the AIEE. This will afford a splendid opportunity for the students to become acquainted with the older members of the electrical industry and to learn of AIEE affairs from the talks made at this meeting.


