U.S. TRUMPS OHIO

Michael Perry, an Ohioan, operated a computer bulletin board for unauthorized exchanges of software. To operate the bulletin board, he used Clark Development Corp. software in an unauthorized manner. Perry was prosecuted for the Ohio crime of "unauthorized use of property". The court's decision addressed the potential conflict between federal law and state law.

The U.S. Constitution limits the areas in which the federal government can legislate. In those areas in which the federal laws apply however, they take precedence over state laws. This is known as "preemption". Where a federal law covers certain activities, it preempts state law, unless the state law has an "extra element". In criminal law, for example, a person cannot be convicted of the same crime under both federal and state law; there must be some difference between the acts required to violate the two laws.

Perry's activities clearly involved copyright infringement, which is a federal crime in some cases. Prosecutor's, however, chose to try him in state court for violation of the Ohio unauthorized use law.

The Ohio Supreme Court determined that Perry's use of Clark's software was merely a copyright infringement. There was no unauthorized use except what was prohibited by federal law. Therefore, any criminal prosecution must be an action in federal court for copyright infringement. Clark could also bring a federal civil action for copyright infringement.

Three of the seven justices deciding the case dissented, however, stating that "use" is different from "copying", so even the judges disagreed on whether the Ohio law was preempted by the federal law. The dissenting judges argued that virtually all software is sold with a license limiting its use. Copyright infringement does not require breach of license. Thus, Perry's breach of the license would provide the extra element that is not required for a copyright infringement. Perry's breach of the license was the "use" that violated the unauthorized use law, and thus provided the "extra element".

The majority of the judges pointed out however, that no license agreement was introduced as evidence. Therefore, it was improper to assume that Perry had violated

any license. This suggests that if a shrinkwrap license had been introduced, the result might have been different. Thus we are reminded of the importance of documenting a license agreement as well as the dangers of breaching agreements.

Nearly every computer user has infringed a copyright or breached a license agreement at some time. Such violations are unlikely to be prosecuted, but the use of criminal prosecution for copyright and other computer related violations of the law is becoming more common. Even though Perry eventually avoided conviction for unauthorized use, he undoubtedly discovered that when computer crimes are prosecuted, it is an unpleasant experience. ■
